TRADING TERMS

Account terms and conditions

- All orders paid Cash on Delivery. Accounts past due date will automatically be placed on hold. Any orders for shipments will be held until all overdue amounts are paid.
- MCH Australia terms are the only terms applicable unless specifically otherwise agreed.
- MCH Australia retains the right to review and alter the terms and conditions without notice.

Pricing

- Prices, terms and conditions of sale are subject to change without notice.
- All Back orders will be invoiced at the prices current at time of delivery.

Orders

- Minimum order value is A\$100 before GST.
- All orders received are subject to acceptance by MCH Australia.
- Back Orders will be supplied unless otherwise notified.

Transfer of products

- The Purchaser shall not sell any product other than from the premises shown as the delivery address on the Purchaser's application for credit to the Company, nor shall it sell any MCH Australia product on the internet or online sales without prior consent of MCH Australia.
- The Purchaser shall not sell any product other than to persons who do not acquire the products for the purpose of re-supply.

Freight

- All orders will incur freight charges to your business premises and be determined by MCH Australia.
- Goods will only be sent via the carrier of our choice.
- All goods sent outside of Australia will have appropriate freight charges applied.

- Freight is not insured unless otherwise specified. MCH Australia does not take responsibility for product that has been damaged or lost in transit.

Lost, Damaged or incorrect shipment

- MCH Australia must be notified of shipping errors within 7 days of receipt of goods. Direct notification to our customer service department via phone / fax or email is required.
- Return Authorisation (RA) numbers must be obtained prior to returning any goods. RA numbers must be clearly marked on the outside of parcels and also on accompanying paperwork.
- Returned goods may be replaced or credited at our discretion.

Payments and Terms

- When making payments please ensure that your account number, invoice numbers and any discounts claimed are clearly itemised.
- Accounts will be charged \$25 for each returned cheque transaction.
- Overdue accounts will attract a 15% late fee and charges reflecting our debt recovery costs.
- Payment is accepted by cash, cheque, Direct Deposit/Funds Transfer only. Cheques should be made in favour of 'MCH Australia'

Agreement to sell.

- Possession of the price list does not constitute acceptance of an offer by the buyer, which MCH Australia in its absolute discretion may accept or reject. MCH Australia may accept the offer by confirmation in writing or by supply of the goods set out in the order by the buyer.
- Risk in any goods supplied by MCH Australia to a customer shall pass when goods have left our Springvale Distribution Centre, but ownership of such goods is retained by MCH Australia until payment is made for the goods and all other goods supplied by MCH Australia to the customer. If such goods are sold by the customer prior to the payment thereof then the proceeds shall become the property of MCH Australia and the customer shall hold such proceeds as agent for MCH Australia.
